**RESOLUTION :** Board considered the matter in detail. Elected Members Shri Mukesh Jain, Shri Anil Agarwal and Shri Neeraj said that no development works were carried out in the last two years. On this PCB stated that even after inviting the tenders twice within 4 months, no bids were received. Elected members told that the condition of Shastri Marg near Judges colony and road near Bata crossing is very poor and need urgent repair or recarpetting. Col. Vaneet Mehta, Nominated Member suggested that the Board can authorize CEO to give this deposit work to MES so that the same work can be completed before the rain starts. CEO stated that the particular road is of land classification A1 under the management of LMA. Further the PCB asked Col Vaneet Mehta to explore the feasibility of maintaining this A1 defence land road if it was proven on records to be deemed as A1 defence land road. The Board resolved accordingly.

Board considered and approved the Annual Administration Report of 2018-19 and the same be forwarded to PD DE SC, Pune.
